### BRIAN BOYLE, JARED LEVINTHAL AND ROBERT WILKINS NAMED 2022 TEXAS “SUPER LAWYERS”

Boyle, Levinthal and Wilkins were all recognized in the Business Litigation category. This marks the 9th consecutive year for Wilkins and 10th consecutive year for Levinthal on the list. It also marks the second consecutive year that Super Lawyers has honored Boyle, a previous Rising Stars honoree.
