His record speaks for itself, obtaining defense verdicts in cases with millions of dollars at stake for clients throughout Alabama and the Southeast, including the first verdict in more than a decade in favor of a defendant product manufacturer in Lowndes County, Alabama. Harlan has served as national counsel for various product manufacturers and is one of only 13 Alabama lawyers selected as a member of the Product Liability Advisory Council (PLAC).

Even beyond the courtroom, Harlan is dedicated to the law. He chairs the Alabama State Bar Committee on Disciplinary Rules and Enforcement, and he is fascinated by the implications technology and social media have on juries and courtrooms. Harlan served as chair of the Board of Directors of the Birmingham YMCA, and he has served as the chair of the Board of Trustees for both Canterbury United Methodist Church and the North Alabama Conference of the United Methodist Church.
